**Information sought:**

The Appellant sought date of receipt and filing of three written submissions diarized under nos. 125805, 125806, 125807 dated 04.04.2016 sent by him with respect to hearing on file nos. CIC/RM/A/2015/000292-SA, CIC/SA/C/2015/000295 and CIC/SA/C/2015/000294 by registry of information Commissioner M. Sridhar Acharyulu; copy of comment/remarks made on them by Hon'ble IC, Sridhar Acharyulu; copies of submissions sent by CPIO with regard to notice of, their date of receipt and remarks of the IC upon them;

copy of CIC attendance sheet signed by Complainant and Respondent for the hearing held on 11.04.2016 and reference of some earlier decision no.

### **Grounds for the Second Appeal:**

The CPIO has not provided the desired information on paras 1(b), 2(b), 2(d) and 3(a) of the RTI Application.

### **Relevant Facts emerging during Hearing:**

The following were present:-

**Appellant:** Present in person.

**Respondent:** A.K. Sharma, Consultant (RTI Cell) & CPIO, Dinesh Kumar, DR to IC(SA) & CPIO, K.L. Das, DR to IC(BJ) & CPIO and R.L. Gupta, DR to former IC(MP) & then CPIO, Central Information Commission present in person.

Appellant stated that he is not satisfied with the reply of CPIO on paras 2(b) and 2(d) of the RTI Application.

CPIO, DR to IC(SA) submitted that regarding para 2(b) he has already given available copy of document to the Appellant which contains the information sought and on para 2(d) list of persons who attended the hearing has also been provided.

### **Decision**

Commission finds no scope of intervention for the information provided on para 2(b) of the RTI Application.

However, on para 2(d), it is observed that Appellant had sought for copy of the attendance sheet and not merely the names; accordingly, CPIO, DR to IC(SA) is directed to provide to the Appellant copy of attendance sheet sought at para 2(d) of the RTI Application after blacking out the personal contact nos. and residential addresses of third parties, if any, figuring therein in consonance with Section 10 of the RTI Act as the same would be exempt from disclosure under Section 8(1)(j) of the RTI Act. Commission's directions should be complied within 15 days from the date of receipt of this order.

The appeal is disposed of accordingly.
